DBC officers have been repeatedly chasing the Planning Inspectorate on this and received the latest response from them last week. This advised that they have a shortage of Inspectors that are suitable for this appeal but this case is on their priority list for allocation as soon as possible. We are unable to provide a date by when the outcome of this appeal will be known. (Reference: APP/T2215/C/20/3259489)</p>	

15	<p><u>Highways</u></p> <p>15.1 Proposed crossing, Southfleet Road for school children to access Pedestrian access to Beacon Woods via the new steps.</p> <p>This access is also the main pedestrian entrance to Beacon Woods for the southern end of Bean</p> <p>KCC have advised that they could look towards an informal crossing point like that which has recently been installed in Southfleet Road Swanscombe this was funded via the Ebbsfleet improvements works. To instigate something like this here we would need substantial funding which we would have to bid for and look to incorporate a 20-mph zone at the same time.</p> <p>RESOLVED</p> <p>That Cllr Munday and the Clerk arrange to meet with the KCC officer to discuss the proposal in more detail.</p>
